

IBPLC Terms and Conditions (T&C)

These terms and conditions are the general terms and conditions that apply to your access and use of this website. These terms of use govern your participation in the prediction of scores for the Premier League and provides information about the conditions you need to comply with once you register to participate. If you participate in this prediction, you will be required at the end to agree to these Terms & Conditions as outlined below.

Thus, by participating, entrants agree to be bound by these Terms and Conditions, or any other requirements set out in related promotional materials. **By accessing this website, you agree that you have read, understood, and agree to be bound by these Terms and Conditions which are posted on our website and as regularly amended.**

These terms and conditions prevail in the event of any conflict or inconsistency with other communication, including advertising or promotional materials.

Promoter:

International Breweries PLC

Eligibility:

1. Participants must reside in Nigeria and be above 18 years of age as at the date of Participation.
2. Participants must at all times during participation have documented proof that they are resident in Nigeria and that they are above 18 years of age and agree to present same upon request by the Promoters.
3. For the **grand prize** gift, Participants must be 19 years of age and above at the end of the Premier League to qualify.

Steps to Participate:

- b. Register following the prompts.

- d. The user scores point on each correct prediction made.
- e. As predictions are made, players can see their points on the leaderboard.
- f. The top three (3) players with the highest scores on the leaderboard get the ₦5,000 (Five Thousand Naira) airtime each week.
- g. At the end of the EPL season, there shall be three (3) winners. Three (3) players with the highest points will stand a chance to win cash prizes as follows:
 - 3rd prize winner will get a cash gift of ₦250,000 (Two Hundred and Fifty Thousand Naira)
